

Corporate Social Responsibility (CSR) Policy

Genmab is committed to building a sustainable and socially responsible biotech, one whose actions reliably benefits patients, stakeholders, and society as a whole.

Our approach to Corporate Social Responsibility (CSR) is anchored in our purpose, values and vision. We are dedicated to further building a sustainable organization that meets those environmental, social and governance (ESG) criteria most relevant to our business, thereby creating long-term value for all of our stakeholders.

At Genmab, we define Corporate Social Responsibility as the way in which we incorporate our purpose (*our unstoppable team will improve the lives of patients through innovative and differentiated antibody therapeutics*), our values (*passion for innovation*; *determined – being the best at what we do; integrity – we do the right thing; work as one team and respect each other*) and our vision (*by 2030, our knock-your-socks-off "KYSO" antibody medicines are transforming the lives of people with cancer and other serious diseases*), with our business operations, our interactions with stakeholders and our commitment to ESG matters.

Genmab's CSR activities are focused on four areas:

- 1. Science-Driven Health Innovations for Patients We use our world-class knowledge in antibody biology and deep expertise in innovative antibody technology to develop cancer treatments to have a positive impact on patients and society.
- 2. **Employee Well-Being and Vitality** We care for our employees' health, well-being, safety and development and promote a collaborative culture that fosters passion for innovation, integrity and respect. We believe that diversity, equity and inclusion are fundamental to achieving our vision and are committed to championing a corporate culture that accepts and promotes uniqueness and empowers each team member to bring their authentic self to work in a safe, open and respectful environment.
- 3. **Ethics and Transparency** We operate our business with the utmost integrity, seeking to do the right thing in all aspects of our business and integrating compliance, ethics and transparency into our business practices, policies and procedures. We maintain a highly ethical organization, promoting our Code of Conduct to employees and engaging with partners and suppliers committed to the same level of ethics in their operations.
- 4. **Environmental and Community Sustainability** We aim to reduce our impact on the environment by refining our processes and incorporating best practices into our operations as we strive to reduce our environmental footprint, minimize waste and decrease use of hazardous material. - Work with partners, vendors and suppliers that understand and share our commitment to CSR

Genmab monitors new developments, regulations and practices and considers implementing when appropriate new CSR-related policies and initiatives that could further enhance our operations as a sustainable and socially responsibly biotech. We have committed to certain United Nations Sustainable Development Goals (UNSDGs) and review and consider additional goals annually. Our Corporate Responsibility Report discloses the main highlights of our corporate responsibility and sustainability initiatives yet does not reflect all our ongoing activities and commitments.

Genmab's CSR activities are governed by a cross-functional CSR Committee, co-chaired by our CEO and SVP of Global Communications & Corporate Affairs and comprised of our COO and representatives from our Human Resources, IPR & Legal, Compliance & Risk and Research & Development functions. The Committee helps set our social responsibility and sustainability strategy and ensures that Genmab carries out all CSR activities effectively and communicates them clearly and openly.

The Nominating and Corporate Governance Committee of Genmab A/S' Board of Directors oversees all aspects of Genmab's CSR efforts and provides recommendations to the Board of Directors regarding social responsibility and sustainability. Additionally, the Board's Audit and Finance Committee oversees our ESG reporting requirements.

This Policy applies to activities undertaken by or on behalf of Genmab. Employees will adopt the CSR considerations described in this Policy into their day-to-day work activities.
